The MSDS is a detailed informational document prepared by the manufacturer or importer of a hazardous chemical. It describes the physical and chemical properties of the product.

A Material Safety Data Sheet (MSDS) is a safety document required by the Occupational Safety and Health Administration (OSHA) that contains data about the physical properties of a particular hazardous substance. MSDS sheets are created for a variety of hazard materials including compressed gases, flammable and combustible liquids, oxidizing materials, poisonous or infectious material, corrosive material and dangerously reactive materials.

OSHA does not require nor encourage employers to maintain MSDSs for non-hazardous chemicals. Consequently, an employer is free to discard MSDSs for non-hazardous chemicals. OSHA began requiring MSDS's for hazardous materials effective May 26, 1986 under 29 CFR 1910.1200, the OSHA Hazard Communication Standard. With the 2012 revision of the HCS, OSHA adopted the Globally Harmonized System and started phasing in SDS's from 2013 through 2016. The differences between MSDS's and SDS's are discussed earlier in this FAQ.
